#### **PRIMARY GOALS & OBJECTIVES**


Turn this County Park into a working forest. Become involved in improving wildlife habitat projects.



#### **Activity Description**

Wildlife habitat improvement - connect with partners associated with EQIP (NRCS Environmental Quality Improvement Program). Elizabeth Marks in the Ghent, NY office can get the list of partners involved in the New England Cotton-tail habitat restoration project. Any projects done in the park should have educational signage associated with it. This will improve public perception and lessen negative imapcts.

White Pine stands - either thin or clearcut these stands to promote regeneration. To maintain a conifer component, it would be beneficial to plant additional pines or spruces in clumps (instead of rows) and fench them to protect from deer.

#### **Activity Description**

Deer exclosures - fencing areas that have been cleared to encourage natural regeneration with out being browsed by the deer. These areas can be any size, and once the vegetation has grown up, the fence can be taken down and moved to another site.
