Applications: 148 Rowe Road – 1010 Holdings – Stefano Ferrari

Mr. Ferrari presented his 197-acre map, requesting a planning board review under the assessment concept of a natural subdivision. The board discussed the concept and was given a short explanation from the Chair. A natural subdivision may occur when land is dissected by a local, state or county road. Mr. Ferrari's presentation showed that his 197 acres are dissected into 4 distinct lots. One lot is on the south side of Route 199, a NY state highway, the other lots are on the north side of Route 199 and are split by Rowe Road, a town road. Mr. Stefano mentioned that a year ago only a form was required to be completed and filed with the assessing authorities for such a split; the procedure now is for such requests to be considered by the local Planning Board. Chaiman Jeffreys made a motion to approve the request as a natural subdivision. Two lots on the East and West side of Rowe Road and one lot off the south side of Route 199 for all new tax grid numbers. Mr. Mautone seconded.

NRI: Chairman Jeffreys mentioned that Supervisor Al Lobrutto has been sharing literature and links from DEC and the Planning Federation on proposed waterbody definitions and training. Ms. Diamond attended a webinar on current regulations and discussed that what has been proposed would be more comprehensive. Chairman Jeffreys suggested that some wetlands would not be visible right now, especially if they were seasonal. The board discussed it at length and asked a fundamental question. "How do you determine what water body is covered and who would be enforcing any new regulation?" Consensus was that the definitions and procedures are not well defined, and should be posed to our consultant, and we should ask what legal rights the Planning Board may exercise in any determination. Chairman Jeffreys stated this will remain under review and will wait to hear from the consultant.
