The Milan Town Board held a Special Meeting on 01/30/2026 at 10:00 AM at the Milan Town Hall to establish an EMS ad-hoc committee.

The Supervisor opened the meeting and the Clerk read the public notice.

**MOTION** by Council. Pike, seconded by Council. Blalock, to establish an ad-hoc committee to address shorter-term Emergency Medical Services (EMS) needs in the town while a longer-term plan is developed.

Discussion: Be pro-active because both BLS and ALS services are effectively not available due to unavailability of Rescue Squad personnel, particularly during the day.

Council. Pike recommended a committee of Kevin Pike, Stephanie Fitzpatrick, Karen McGlee, Larry Brody and Jeff Galm. The committee will discuss a joint plan with the county. \$1.4 million has been established for Empress, but no ambulance service is included in the northern part of the county. Northwell bought Nuvance, but the budget is set for 2026, so the effort will be toward a temporary fix while working toward a 2027 solution.

Greenport Ambulance may be providing services to Milan; Council. Blalock will follow up on this information.

Council. Pike will follow up with Chris Drago and Northwell.
