Local Law No. 2 of 2026, entitled:

“Local Law Amending Town Code Section § 200-36. Short-Term Residential Rental”

BE IT ENACTED BY, the Town Board of the Town of Milan as follows:

1. Section 36 (Short-Term Residential Rentals) of Chapter 200 (Zoning) of the Town Code is hereby amended by repealing and removing the existing sub-section B.(8) and adding a new sub-section B.(8) which shall read as follows:

B. Operation Requirements and Standard Conditions for all Short-Term Rentals:

- (8) All short-term rentals must comply with the provisions of the Uniform Code, as amended. *See* Chapter 121 - Fire Prevention and Building Construction. The requirements of the Uniform Code include but are not limited to the short-term rental maintaining the required number of functioning smoke alarms, carbon monoxide detectors and fire extinguishers with proof of annual recharge attached and having at least two compliant means of ingress/egress for each bedroom in the short-term rental.

2. Section 36 (Short-Term Residential Rentals) of Chapter 200 (Zoning) of the Town Code is hereby amended by adding a new sub-section B.(9) which shall read as follows:

B. Operation Requirements and Standard Conditions for all Short-Term Rentals:

- (9) The owner of the short-term rental shall post a copy of the short-term rental certificate and a copy of chapter 200 of the Town Code in a conspicuous place within the short-term rental. In addition, the owner of the short-term rental shall provide each responsible person utilizing the short-term rental with the following information prior to their occupancy of the short-term rental:

- (a) The 911 address of the short-term rental for fire and/or medical emergencies;
- (b) The names of the authorized local agent and owner of the short-term rental with telephone numbers where these parties can be reached on a twenty-four-hour basis;
- (c) The maximum number of overnight occupants permitted to stay in the short-term rental, the maximum number of daytime occupants permitted in the short-term rental and the maximum number of individuals permitted on the property where the short-term rental is located;
- (d) Notice that all lodgers and visitors to the short-term rental are required to park in a designated paved parking area located on the lot where the short-term rental is located and not in or along any public roadway or on any lawn or vegetated area of such lot;

- (e) Notice indicating the trash pickup day and applicable rules and regulations pertaining to leaving or storing trash or refuse on the exterior of the property;
- (f) Notice regarding the applicable rules for pets at the short-term rental;
- (g) Notice that the responsible person(s) utilizing the short-term rental may be cited or fined by the Town for violations of this chapter;
- (h) Notice that the responsible person(s) utilizing the short-term rental may be evicted or removed by the owner of the short-term rental in accordance with state law, in addition to any other remedies available at law, for creating nuisances, disturbances or otherwise violating the provisions of this chapter.
- (h) Notice that the failure to conform to the occupancy requirements of the short-term rental unit is a violation of this chapter.

3. Section 36 (Short-Term Residential Rentals) of Chapter 200 (Zoning) of the Town Code is hereby amended by repealing and removing the existing sub-section C.(3) and adding a new sub-section C.(3) which shall read as follows:

C. Short-term Rental Certificate. All Short-Term Rentals shall require a Short-Term Rental Certificate as described below:

3. A short-term rental certificate issued under this section shall require renewal by the Zoning Enforcement Officer no later than the anniversary of such issuance, if the property is to continue to be operated as a short-term rental. The owner must request the renewal in writing from the Zoning Enforcement Officer at least 90 days prior to such anniversary. Failure to do so may result in the lapse of the short-term rental certificate. Within 30 days after receipt of a renewal request, the Zoning Enforcement Officer shall review whether the short-term rental is in compliance with the terms of its short-term rental certificate. **As a prerequisite to granting or renewing a short-term rental certificate, the Zoning Enforcement Officer must be allowed access to the short-term rental unit for the purpose of verifying compliance with the provisions of the Town Code, which includes the Uniform Code.** The Zoning Enforcement Officer shall have the discretion to renew, amend, or deny the renewal of the short-term rental certificate for good cause shown, which may include considerations of violations of the Town Code at the short-term rental unit as well as considerations of noise, disorderly conduct, or public safety at the short-term rental unit. No short-term rental shall be permitted at any time when a valid short-term rental certificate is not in effect.
4. The invalidity or unenforceability of any Section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional, shall not affect the validity or enforceability

of any other Section, subsection, paragraph, sentence, clause, provision, or phrase of this Local Law, which shall remain in full force and effect.

5. This Local Law is adopted pursuant to § 261-263 of the Town Law and § 20 of the Municipal Home Rule Law of the State of New York, which authorize the Town to adopt zoning provisions that advance and protect the health, safety, and welfare of the community.
6. To the extent that any provision of this chapter is inconsistent with Town Law §§ 263, 274-a, 274-b or any other provision of Article 16 of the Town Law, the provisions of this chapter are expressly intended to and do hereby supersede any such inconsistent provisions under the Town's municipal home rule powers, pursuant to Municipal Home Rule Law §10(1)(ii)(d)(3); §10(1)(ii)(a)(14) and §22 to supersede any inconsistent authority.
7. This Local Law shall take effect immediately upon filing with the Secretary of State.

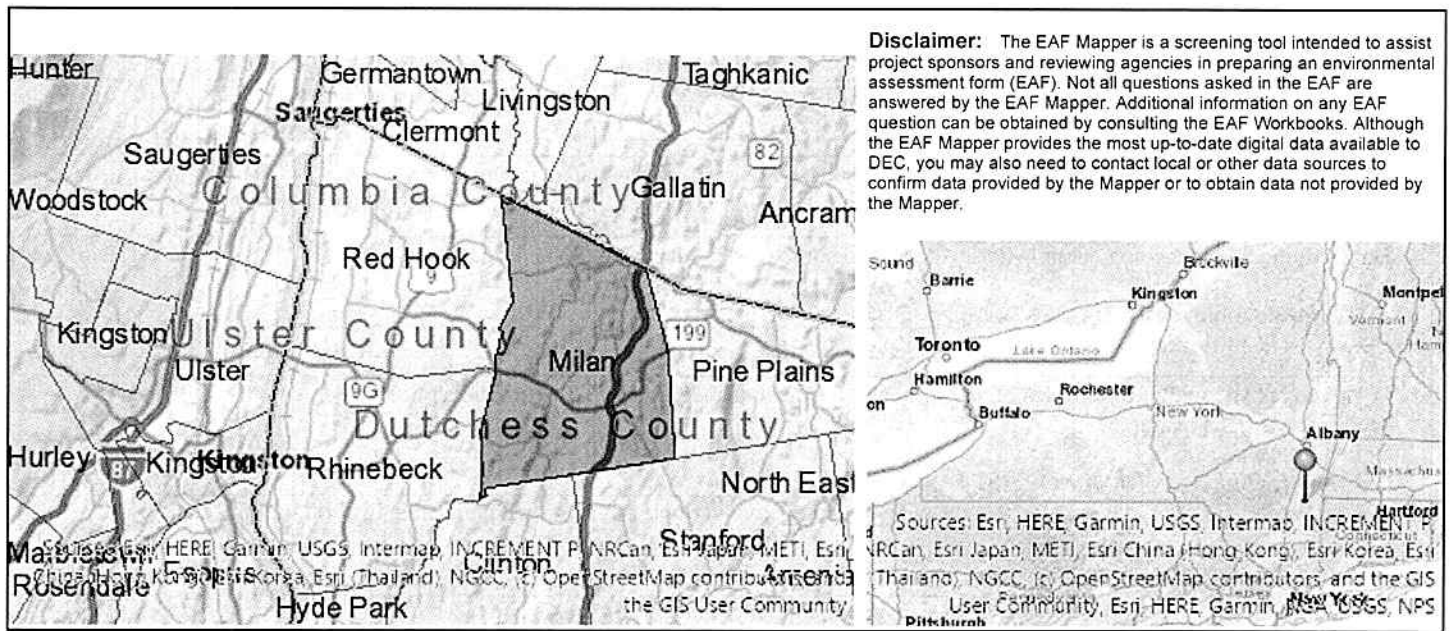
